




Paper recycling increases the material lifespan and is a **key strategy to reduce less environmentally friendly end-of-life options** such as land-filling of biodegradable material and also incineration in thermo-valorisation plants













Since paper **for recycling** is not only recycled in the country where it is produced, some essential features such as **ecodesign** and **ecocollection** concepts must be developed at transnational level to increase the sustainability of the paper loop.

Improper collection systems can drastically reduce the amount of paper being recovered for recycling; and **improper design of a graphic or packaging product** can make is useless or even harmful for the recycling process.

- collection systems are different




